Polycyclic Aromatic Hydrocarbons

Polycyclic aromatic hydrocarbons (PAH) are hazardous pollutants. We test our products in cooperation with TÜV-Süd to make sure they are free from hazardous substances.

To do this we use the stricter limits which are applied for the TÜV-tested safety seal (TÜV-GS). Thus, we ensure safe and confident handling of our products.

RoHS (Restriction of the use of certain Hazardous Substances)) Directive 2015/863/EG and 2011/65/EU.

Our products comply with the RoHS Directive. We follow all the valid legal regulations.

Furthermore, we work in accordance with the following directives:

You will receive safety data sheets with information on the product substances in order to comply with the requirements of the REACH-Directive (**R**egistration, **E**valuation, **A**uthorisation of **CH**emicals): Directive (EU) No. 2008/1272). In our product range there are no substances of high concern (SVHC). All relevant substances of our supplier products are registered insofar as these substances need to be registered. In accordance with our supplier agreement we only receive REACH-compliant products.
